Please be advised that non-profit organizations, such as this one, which do business in Massachusetts as public charities are required to register and file annual financial reports with this Division pursuant to G.L. c.12, § 8E-8F. We have accordingly registered your organization as a public charity pursuant to G.L. c.12, § 8E.

Please visit our website at www.ago.state.ma.us. We suggest you review the general laws booklet, as well as "Questions Commonly Asked to the Division of Public Charities" and "Guide to the Registration and Filing Requirements of the Division of Public Charities."

Your organization's annual financial report (Form PC) will be due four and one half months after each fiscal year ends. There is an annual filing fee which is determined by your organization's total gross support and revenue. Form PC and instructions are also available on the website mentioned above.

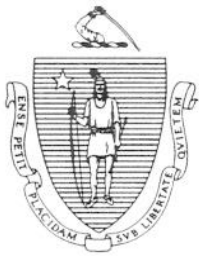
If, and only if, your organization is still within its first year of existence, and you intend to solicit funds from the public, your organization must complete Short Form Schedule A-2, which you can also obtain from our website. Pursuant to Mass. G.L. c.68, § 19, non-profit organizations must apply for and be issued a certificate of registration each year prior to solicitation from the public.
